### GENERAL AGREEMENT FOR COLLABORATION

between

1. Both parties agree to encourage the following activities, in particular to promote academic cooperation:

The specific areas identified for collaborative activities between two parties are as follows

- M/s Triphase Pharmaceuticals Pvt Ltd, Hebbal, Mysuru will facilitate educational factory visits, supporting the academic programs of both 'Bachelors in Vocation' and 'Masters in Vocation' course students with customized topics after mutual discussion between both parties.
- The factory visit programs will be limited to two for each of the semester.
- M/s Triphase Pharmaceuticals Pvt Ltd will agree to be Member of the Academic bodies constituted to manage and advise on these programs.
- M/s Triphase Pharmaceuticals Pvt Ltd would provide knowledge-based support to the academic programs upon mutual agreement.
- M/s Triphase Pharmaceuticals Pvt Ltd would provide the opportunity of internships as per mutual agreement.

Before these activities can be implemented, both parties shall discuss the opportunities and challenges involved to the satisfaction of each party based on the mutually agreed objectives and outcomes of the relationship.

2. This General Agreement shall become effective as on the date of signature of both parties for a period of three years. The Agreement may be amended by the written consent of the parties.

3. This Agreement may be terminated by either party with a minimum of 120 days written notice.

4. *IT is mandatory that all students or interns will sign a confidentially agreement prior to any training.*  
Activities in progress at the time of termination of this agreement shall be permitted to conclude as planned unless otherwise agreed.
