**MEMORANDUM OF UNDERSTANDING**

for the purpose of Academic Cooperation

The general objective of this Memorandum of Understanding (MOU) is to stimulate and facilitate the development of collaborative and mutually beneficial programs which serve to enhance the intellectual life and cultural development between two organizations, and contribution to increased academic cooperation. Thus, JSS College of Arts, Commerce and Science, Ooty Road, Mysuru and GOVERNMENT FIRST GRADE COLLEGE OF ARTS SCIENCE AND COMMERCE, SIRA have agreed that in support of their mutual interests in the field of education, research and extension activities:

The two organizations will:

- a) Cooperate in the exchange of information relating to their activities in teaching and research in fields of mutual interests
- b) Promote appropriate joint research projects and joint courses of study
- c) Endeavor to encourage students and staff for a formal Exchange
- d) conduct short courses, as mutually agreed in writing between the parties prior to commencement of this activity
- e) conduct study tours, as mutually agreed in writing between the parties prior to commencement of this activity

The aim of the Memorandum of Understanding shall be to achieve a broad balance in the respective contributions and benefits of the collaboration, and this shall be subject to periodic review by both the organizations.

The two organizations agree to assist in the seeking of appropriate work space, library and technical facilities as appropriate.

In the implementation of specific cooperative programs, a written agreement covering all relevant aspects including funding and the obligations to be undertaken by each party will be


Either party may terminate the agreement at any time during the term by the provision of three months written notice to the other party.
