REASONS:

The Managements of some of the Private Aided Colleges had appointed Lecturers in their respective Colleges on Full-Time Stop-gap basis with a consolidated salary of Rs. 1040/- P.m. As some of these Lecturers were working for a number of years, they approached the Hon'ble High Court of Karnataka for absorption into regular service. The Hon'ble High Court in W.P. No. 6232-35/90 and other connected cases dated 3-7-90 and 31-7-90 passed judgement to give an opportunity to these Stop-gap Lecturers to undergo the due process of selection through regular selection committees. Accordingly, the selection committees were constituted and candidates selected. As some of these Stop-gap Lecturers who were not selected owing to reservation policy of the State Government, obtained stay from Hon'ble Supreme Court of India in W.P.No. 873/90. As such, status-quo which prevailed before the selection of the candidates through selection committees, was maintained. Finally the Hon'ble Supreme Court of India delivered a Judgement on 29-1-92 for absorption of Stop-gap Lecturers having more than three years of service as on 29-1-92. Accordingly, proposals were sent to the Government for absorption of such eligible Stop-gap Lecturers vide this Directorate's letters under reference(2) above. Approval of the Government is obtained vide letters under reference (3) above. Hence this order.


Her appointment is subject to the following terms and conditions.

1. She will be on a pay of Rs.21600, 75 % Dearness Allowance, 20% House Rent Allowance and Rs. 300/- City Compensatory Allowance on a pay scale of Rs. 21600-45100. This salary is subject to changes in the salary rules of vidyapeetha.
2. This order will come into effect from 01.07.2022.
3. She will be on probation for a period of two years from the date of reporting for duty. The Management may extend his probation for a period of one year. If she wants to leave the job during this period. One month's notice must be given or one month's salary must be paid.
4. She may be discharged from service without giving any reason or notice either during the probationary period or during any further probationary period. She shall continue on probation unless ordered in writing to satisfactorily complete the probationary period.
5. After completion of two years of service, in the review committee meeting about her satisfactory performance will be reviewed in a review committee meeting for satisfactory performance. If the work done is satisfactory, will be declared satisfactorily completed. Otherwise probation period may be extended for another year. However, if the service is not satisfactory, she will be informed in advance and withdraw her from the service.
6. She is the full time employee of the college and she is not permitted to engage in any other business or job directly or indirectly.
7. Her appointment is on the documents and information provided by them on any time. If the given information is found not correct or if they are hiding any information that is to be disclosed to the Organization. Will be terminated from duties without prior information.

8. The service is transferable in obligation all ways. She can be transferred to JSS Mahavidyapeetha and its subsidiary organizations, JSS Medical Service Trust and other Trusts, JSS AHER and subordinate to it, which are existing and can be created in future.
9. Apart from her duties she has to handle the duties and responsibilities the management assigns.
10. After the confirmation of her appointment the management may without giving any reason terminate her services with 3 months prior notice. In case the employee wishes to leave the job she has to give 3 months prior notice or she must pay 3 months' salary to the management in order to get herself relieved from her duties
11. The employee should become compulsory member of the Provident Fund and Group Medical Insurance Schemes.
12. At the time of reporting to the duty, she has to handover all the original documents and certificates to the higher authority.
